Enrollees have the right to receive care and services in a timely manner: access to a routine eye exam within 30 calendar days; access to non-urgent medical needs within seven days; access to urgent care if the call is received during office hours, and the doctor determines the need of the member to be urgent, member should be seen within 24 hours; access to a telephone screening when evaluated to determine the severity of the condition and disposition of the patient; and access to specialty care within 14 calendar days from the time the primary care provider requests the referral.*
